

## NOTICE OF PUBLIC HEARINGS

### 2025 - 2029 FIVE-YEAR CONSOLIDATED PLAN/ 2025 ANNUAL ACTION PLAN

The West Virginia Department of Economic Development (WVDED) and the West Virginia Housing Development Fund (WVHDF) are conducting public hearings concerning the State of West Virginia's 2025-2029 Five-Year Consolidated Plan and FY2025 Annual Action Plan (AAP) for funding provided to the State by the U.S. Department of Housing and Urban Development (HUD).

The plans will guide the expenditure of approximately \$26,634,139 in expected annual HUD funding for housing and community development needs for fiscal years 2025-2029. The following programs and notified funding allocations are included in the FY2025 AAP: Community Development Block Grant (CDBG) \$13,783,001 in non-Entitlement areas; HOME Investment Partnerships Program (HOME) \$4,832,979.21, Housing Trust Fund (HTF) \$3,134,373.20, Emergency Solutions Grant (ESG) \$1,805,460, and Housing Opportunities for Persons with AIDS (HOPWA) \$849,715, statewide. **Please note, proposed activities' budgets are estimates and will be proportionally increased or decreased from the estimated funding levels to match actual allocation amounts.**

The FY2025-2029 Draft Consolidated Plan, FY2025 Draft Annual Action Plan, and the Draft Amended Citizen Participation Plan will be available on the WVDED website at <https://wvcad.org/resources>, the State's Regional Planning and Development Councils (RPDC)s, and by calling the WVDED at 304-957-2068. The draft plans will be available for public review beginning Friday, June 27, 2025 until close of business Monday, July 28, 2025 and will be submitted to the U.S. Department of Housing and Urban Development (HUD) on or about August 14, 2025.

Public hearings will be held to review the 2025-2029 Consolidated Plan and FY2025 Annual Action Plan, the Analysis of Impediments, and to receive written and verbal comments on the dates below. The written comment period begins on Friday, June 27, 2025 and written comments must be received in the West Virginia Department of Economic Development at the address below or submitted via email to [wv.consolidated.plan@tidalbasingroup.com](mailto:wv.consolidated.plan@tidalbasingroup.com) by the close of business on Monday, July 28, 2025.
