Although Self-Certification for Non-Duplication of Benefits is a stand-alone requirement, further monitoring can be conducted by the Subrecipient to ensure the applicant has not falsified the form. Below are contacts for WV CDBG programs receiving funds for COVID-19 (CARES ACT) public assistance from Housing and Urban Development (HUD). Contact each program as needed for further confirmation of Non-Duplication of Benefits.

CSBG (Community Services Block Grant)

ESG (Emergency Shelter Grant)

ESG prioritizes 30% AMI or lower, providing up to 6-months of rental or utility arrears. For households protected by CDC eviction moratorium, assistance is not eligible. All counties have coverage of ESG RRH (currently homeless) and HP (at-risk of homelessness) rental assistance.

CDBG (Community Development Block Grant)

CDBG provides up to 6 months of rental, mortgage, and utility assistance with prioritization of 80% low/moderate income persons. To receive assistance, there must be a direct tie-back to COVID-19 determined by a brief description how the household was affected. When assistance is granted, CDBG-CV funds will be in the form of a direct payment to the landlord, lender, or utility provider.

For the first allocation of CV funds (CV1), the following projects have been awarded:
